This HRA account reimburses you for certain deductibles and coinsurance amounts up to \$500 /employee or \$750 /employee + spouse and employee + children or \$1,000 /family	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Prescription Drugs and Preventive care for In- Network Providers .
